

Financial Literacy Task Force

"Financial Literacy on Campus: Raising Awareness, Creating and Developing Programs, and Improving Effectiveness," chronicles the growth and development of two financial literacy programs out of the student loan and student financing services offices at two COHEAO members, Duke University and the University of Illinois. This insightful whitepaper emphasizes the importance of the issue and the potential return on investment (ROI) for all stakeholders in the higher education community.

Irene Jasper, Director of Student Lending at Duke University chronicles the creation of the "PersonalFinance@Duke" program and Andrea Pellegrini, Assistant Director of University of Illinois' Student Money Management Center (SMMC), reviews how University Student Financial Services & Cashier Operations (USFSCO) at the University of Illinois targets its limited resources to provide these services to the students who may benefit the most. Kris Alban of iGrad, and COHEAO's new Co-Chair of Financial Literacy, highlights three key variables for making financial education programs effective, while COHEAO's Wes Huffman examines the federal role on this important issue.

In addition to reviewing the two campus programs and offering insights on improving financial education on your campus, the COHEAO Financial Literacy Awareness White Paper provides a listing of numerous websites and books to assist you in the development of financial literacy programs at your campus or organization. COHEAO's Task Force continues to offer a multitude of training opportunities on financial education topics, through webinars and at the Annual and Mid-Year national conferences.

COHEAO Conferences and Webinars

The Agenda Committee organizes two conferences a year and at least one webinar each month. These events are designed to provide timely information to COHEAO members to assist them with regulatory and legislative updates, best practices and other topics of importance in Higher Education. This year's annual Conference in Washington D.C. boasted a significant increase in attendance. Staff from the House Education and Workforce Committee majority and minority and from the Senate Deputy Majority Leader gave their thoughts on the new Congress and what might transpire on higher education issues, and they also gave tips on visiting Congressional offices. Then, on a summerlike afternoon (in January), dozens of COHEAO members took the Washington Metro to Capitol Hill and fanned out to visit Congressional offices and advocate for funding for Perkins Loan cancellations. Federal Perkins Loan Program

COHEAO is currently viewed as the sole voice for Perkins right now. Our Board of Directors have a quarterly meeting in D.C. on April 15th, and will be visiting with several key members of the House and Senate to continue the fight for funding for cancellation reimbursements and federal capital contribution.

The funding for cancellation reimbursements to colleges, although appropriated, has remained unfunded for the past 3 years. Reimbursements have not been made to colleges since the 2008-09 award year and even back then it wasn't funded at 100%. The Department of Education estimates that colleges are owed about \$300 million dollars in unfunded cancellation reimbursements at this time. This is growing significantly each year. These monies are desperately needed in the Perkins fund and should be reimbursed as provided for in the Higher Education Act. Without these reimbursements, the revolving fund will continue to diminish each year.

We believe that seeking restoration of funding for the capital contribution, although a much tougher argument to sell, is still worth making. Because institutions are required to match new federal contributions, schools are vested in this program, which is a win-win situation for the federal government, the school and the student borrowers. It provides program growth while encouraging fiscal responsibility and due diligence in managing this program.

In the coming year, COHEAO will continue to encourage the membership to play an active role in educating our congressional representatives on the value of the Perkins Loan Program. Please visit members, both in your home districts and in DC, and share the benefits of this unique and critical program.

This past year, as a result of the new restrictions placed on the number of semesters that a student can receive a Pell grant, thousands of students lost their Pell funding. This is only expected to grow in the coming years. As students are increasingly challenged due to rising costs and decreases in funding, the Perkins Program can bridge that need-gap and make the difference in whether a student continues their education or is forced to drop out.

As we have seen in the past, it only takes one champion in Congress to spark a flame that can quickly spread. We need to rally our Perkins supporters once again to champion and revitalize this essential program.

With reauthorization of the higher education act slated to occur in 2013, we will take this opportunity to work with our membership to bring forward a proposal which maintains the core values of the Perkins program while adapting to the realities of the current fiscal and political environment.



A CLEAR PATH TO PAYMENT – SIX-PRONGED PLAN

December 2012

If families have more information about budgeting and paying for college, fewer students might drop out for financial reasons. Five years ago, the University of Illinois embarked on a six-pronged communication plan to help students and parents find their way:

- Parent Open Houses held during freshman move-in week, to discuss student accounts, student confidentiality, costs, billing cycle, direct deposit, payment plans, late payment policy, and education tax credits, and demonstrate online services.
- Webinars run through summer and early fall, after hours, and Saturday mornings, with time for Q&A, and staff available for online chat.
- Payment plans established for a set enrollment fee, either annual with 9 to 12 payments, or a semester with 3 to 6 payments. Year 1: 1,887 participants; Year 4: 8,380 participants.
- Individual consultations with freshmen and/or parents arranged in person or over the phone; reduced call volume during peak periods by 15%.
- Web site redesign was accomplished, with assistance from outside consulting firm, for easier navigation and visual appeal.
- Student Money Management Center was created to provide students with financial education and resources to manage finances both in school and post-graduation; staffed by one employee and graduate students, to work with students on past due balance resolution. Students are required to sign an agreement, enroll in auto draft, create a balanced budget, and complete the iBudget Financial Literacy program.

The end results have been decreased call volume, improved work quality for staff, lower outstanding receivables, reduced staffing needs, and cost savings with 98% direct deposit enrollment.

HOW FAMILIES PAY COLLEGE EXPENSES

April 4, 2013

In 2012-13, grants from all sources and education tax benefits covered 36 percent of the total cost of attendance for full-time undergraduates, according to a new analysis of higher education pricing and financing trends from the College Board. Student loans accounted for 26 percent of total charges, while parents' and students' other resources, such as employment earnings and savings, covered the remaining 38 percent of postsecondary expenses.

OBAMA'S 2014 BUDGET REQUEST REFORMS STUDENT LOAN INTEREST RATES

April 11, 2013

President Obama's budget recommends the restructure of federal student loan interest rates so they are determined by the cost of government borrowing and are therefore more closely aligned with market rates. Specifically, rates would be constructed by using the base 10-year Treasury note rate ("T-bill") plus add-ons of:

- .93 percentage points for Subsidized Stafford Loans
- 2.93 percentage points for Unsubsidized Stafford Loans
- 3.93 percentage points for PLUS Loans (Grad PLUS & Parent PLUS)

If those rates were in place currently, it would be more favorable for students than the existing fixed rate policy, at least in the current years. Subsidized Stafford Loans would have an estimated 2.9 percent rate, Unsubsidized Stafford Loans a 4.9 percent rate, and a 5.9 percent rate for PLUS loans. The proposal calls for interest rates to be determined annually and then fixed for the life of loan, mirroring the variable-fixed approach NASFAA has supported and advocated since last year. The President's budget request does not place a cap on interest rates.




